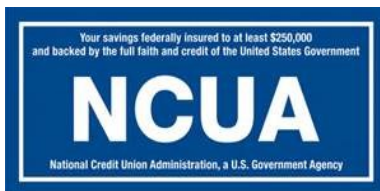
Dividends Declared for 2nd Quarter 2021



The Board of Directors has authorized the following dividends for the quarter April 1, 2021 through June 30, 2021:

- \$500—\$5000: APR 0.050%, APY 0.050%**
 - \$500—\$20,000: APR 0.050%, APY 0.050%**
 - \$20,000 and above: APR 0.100%, APY 0.100%**
 - Youth Account: APR 0.149%, APY 0.150%**
 - IRA: APR 0.199%, APY 0.200%**
 - 6 month CD: APY 0.10%**
 - 12 month CD: APY 0.20%**
 - Dividend Checking: APR 0.050%, APY 0.050%**
 - Xmas & Vac. Club: APR 0.050%, APY 0.050%**
