The Board of Directors has authorized the following dividends for the quarter April 1, 2022 through June 30, 2022:

- \$500—\$5000: *APR 0.020%, APY 0.020%*
 - \$5000—\$20,000: *APR 0.040%, APY 0.040%*
 - \$20,000 and above: *APR 0.060%, APY 0.060%*
 - Youth Account: *APR 0.060%, APY 0.060%*
 - IRA: *APR 0.150%, APY 0.150%*
 - 6 month CD: *APY 0.80%*
 - 12 month CD: *APY 1.00%*
 - Dividend Checking: *APR 0.020%, APY 0.020%*
 - Xmas & Vac. Club: *APR 0.020%, APY 0.020%*
- *APR reflects the annual percentage rate.
